AP Alternative Assets in turn distributed these 22,507,327 Class B common shares to its unitholders, including 40,544 Class B common shares to Apollo Principal Holdings III, L.P. and 444,952 Class B common shares to AAA Holdings, L.P. Except for the Class B common shares that were distributed to AAA Associates, Apollo Principal Holdings III, L.P., AAA Holdings, L.P. and certain other unitholders associated with the reporting persons, all Class B common shares distributed by AP Alternative Assets automatically became Class A common shares upon such distribution.
