("AAA Guarantor"), dated as of September 11, 2020 (the "Agreement"), AAA Guarantor sold, and the Issuer repurchased, 605,554 Class A Common Shares ("Class A Shares"). The sales were necessitated by the liquidation of AP Alternative Assets, L.P. and related entities (together, "AAA"), including (i) to pay outstanding liabilities and expenses of AAA in anticipation of its final liquidation and (ii) to pay residual cash distributions upon the final liquidation of AAA to limited partners (including limited partners affiliated with the Filing Persons) in an amount equal to such limited partners' pro rata share of the remaining value of AAA after payment of all expenses (the "Residual Value"). The share repurchase was approved by the Issuer's Conflicts Committee on September 10, 2020, for the purpose of, among other things, exempting the dispositions under Exchange Act Rule 16b-3.
